## 31 December 2015: Demistan Case

The **Fourth Criminal Court** revoked the nationality of **23 individuals** on terrorism charges, for forming a terrorist group, using explosives, and killing a police officer.

**One defendant**, Hussein Abdulla Khalil Ebrahim, was sentenced to death. The other **22** received life sentences.

**Two juveniles**, Jassem Mohammad Rashed Khalil Ebrahim and Hussain Mohammad Ahmed Fallah, were sentenced to life and stripped of their nationality. **Three defendants** were students.

**All but one** of the defendants are from Demistan village.

## 29 December 2015: Criminal Case

The **Fourth Criminal Court** revoked the nationality of **2 individuals** on terrorism charges. In the same trial, 27 other defendants received sentences ranging between five years and life imprisonment. Further details of the two defendants stripped of citizenship are not known to BIRD at the time of writing.

## 5 November 2015: Criminal Case

The **First Criminal Court** revoked the nationality of **five individuals** on offences including espionage-related activities within Bahrain on behalf of the Iranian government, planning terrorist attacks in Bahrain, and receiving training on the use of weapons and explosives.

**All five** of the defendants received life sentences, **two in absentia**.

## 11 June 2015: Bani Jamra Case

The **First Criminal Court** revoked the nationality of **56 individuals** on terrorism charges, for forming a terrorist group and using explosives.

**Five** defendants received life sentences.

**29** defendants were sentenced to 10 years in prison.

**22** defendants were sentenced to 15 years in prison.

**One** defendant was sentenced to 3 years in prison.

**Nine** of the defendants were **juveniles** (below 18) and **27 were students** (almost half of the total number of people sentenced on June 11<sup>th</sup>).

**41** of the defendants are from the village of Jamra.

## 31 January 2015: Ministerial Order

The **Minister of Interior** revoked the nationality of **72 individuals** on terrorism charges.

The list includes **peaceful civil society members**, including bloggers, journalists, political activists and human rights defenders.

Among the named are BIRD's Director of Advocacy **Sayed Ahmed Alwadaei**; blogger **Ali Abdulemam**, who was sentenced to 15 years in prison in absentia for running an online news forum; **Dr. Ali Al-Dairi**, founder of the online news site Bahrain Mirror; journalist **Abbas Busafwan**; university professor **Masoud Jahromi**; and former opposition Member of the National Assembly **Shaikh Hasan Sultan**.

Mixed with these members of civil society are **twenty persons** affiliated with ISIS and Al Qaeda.
